



II. PARENT ENGAGEMENT IN DEVELOPING AND REVISING THE POLICY

Paredes Elementary's Parent Advisory Committee consisting of campus parents, teachers, principals and community members developed the campus Family Engagement Policy. The Family Engagement Policy will also be distributed to parents. Parents will be given the opportunity to offer their suggestions for any revisions to the policy. Parents may also volunteer to serve on either the district-wide and/or individual school's advisory committee or both.

The annual Title I-A meeting will be held at flexible times to increase the opportunity for parental participation. English and Spanish translation will be available. Written notices in both languages will be sent to parents notifying them of the date and times of the meetings. Parent volunteers, parent trainers, and parent liaisons will also contact other parents by phone regarding the meetings. Volunteers who speak both English and Spanish will make all contacts.



V. TYPES OF FAMILY ENGAGMENT

Paredes Elementary will provide opportunities for parent engagement to become involved in their children's education. Many types of family engagement are needed in school-home-community partnership to help all children succeed. All parent and community volunteers must comply with the district policy regarding State of Texas background checks.

Each year Paredes Elementary will assess the needs of parents and children in the community through a variety of measures, including parent surveys, so that Title I programs can be tailored to meet those needs. VIII. EVALUATION


